

Nevada State 4-H Shooting Sports Advisory Committee Meeting January 12, 2011...6:20pm

Committee Members attending were: Ron Huntington, Pete Mangum, Sandy Wallin, Rich Knight, Lori Leas, Will Whitten, and Steve Schafer.

Absent Committee Members were: Vern Marion

Guests attending were: Greg Wright (Carson City), Mary Regan (Las Vegas), Rick Highland (Elko), and Jessica Poole (State 4-H Office).

The meeting was called to order at 6:20pm by Steve and he also served as recorder. The meeting was delayed twenty minutes due to technical difficulties with the UNR Interactive Video System.

Rich made the motion to approve the minutes of the November 10, 2010 meeting that were distributed with the announcement of this meeting. The motion was seconded by Sandy and it unanimously passed.

Sandy made the motion to approve the Shooting Sports Sales Account Financial Statement (January 2011) that was distributed with the announcement of this meeting. The motion was seconded by Lori and it unanimously passed.

Steve provided an update on the April 8-9, 2011 Shooting Sports Instructor Training and Certification to be hosted by Douglas County. The draft of the Information and Registration Packet had been sent to Douglas County for final revision and updating. He said the revisions are due back to him by Friday, January 14th and he hoped to get it distributed within a week or two after receiving it on January 14th.

Clark County is hosting the Fall Training/Certification and Mary Regan (Clark County) offer two possible dates for this event. The dates offered were the last weekend in September or the last weekend in October. After discussion, Lori made a motion to have a three-day training/certification (Friday Evening, Saturday, and Sunday Morning) at the new shooting range in Las Vegas on September 30th (Friday), October 1st (Saturday), and October 2nd (Sunday). The motion was seconded by Sandy and it unanimously passed.

The next item of business was the National 4-H Shooting Sports Invitational Contest to be held in San Antonio, Texas (June 19-24, 2011). Steve asked if the form and format used last year to select the Nevada Participants was acceptable for this year or if the committee wished to do something different. Will made the motion to follow use the form and format from last year (meaning Steve will distribute the form within the next week or two and the interested youth will be interviewed by this committee at the meeting to be held on March 9, 2011). The motion was seconded by Rich and it unanimously passed.

The next business item was carried forward from the last meeting due to everyone not receiving the entire revised document concerning the Administration, Organization, & Operation of the Nevada 4-H Shooting Sports Program prior to the last meeting. The sixteen page document was discussed by the committee and each committee was individually asked about their thoughts/suggestions, because it was believed everyone should be allowed to voice their opinion. Pete made the motion to accept the document as presented, with two exceptions: (1) add wording to the committee selection section that indicates acceptance of individuals by the committee; and (2) additional wording to clarify the definition of "Assistant 4-H Shooting Sports Instructors" (Steve was requested to incorporate these revisions into the document, in red font for ease of distinction, and these would be presented at the next meeting and voted on at the next meeting). The motion was seconded by Sandy and it unanimously passed.

The last item of business was an update by Sandy about the 2011 State 4-H Shooting Match. She stated the both ranges in Carson City had been reserved and the date for the contest (as previous approved by this committee) is Saturday, September 17, 2011. She indicated some possible revisions for the 2011 Contest and Steve asked her compile this for presentation at the March 9, 2011 meeting. She agreed.

Sandy made the motion to adjourn the meeting. The motion was seconded by Pete and the motion passed. The meeting was adjourned at 7:16pm.

The next committee meeting is scheduled for Wednesday, March 9th (6pm-8pm).
